 - a. Consider ratios from when enrollment and faculty numbers were stable; 2014-2016
 - b. What is optimal student: faculty ratio (or estimate, as described in 3.a. above)?
- 8. Eric showed graph reflecting declines in BUFMs, Student headcount, Student credit hours. Discussion ensued. Do we need the adjunct numbers to evaluate numbers of teachers in the classroom? If faculty attrition is one year behind student numbers, would attrition quietly meet the ratio? Can we expect a levelling out of enrollment?

 - a. Who has the burden of proof/responsibility regarding what to expect in the future?
 - b. Do projections really matter if this committee's recommendations are keyed to different scenarios and timing? Those scenarios and timings will be realized or not, regardless of what was projected beforehand.
